Meeting called to order 7:34 PM CST by President Billy Hodges. The main purpose of the special meeting is to discuss specific deadlines for the April 2022 ATFTC National Specialty and concurrent specialties to be held in Perry GA. And discussion of nominations as presented from Rick Lilly, Nomination Chair.

The nominating committee consisted of Rick Lilly, chair. Susan McCoy, Sheryl Irwin and Chris Bowker. Alternates were Lila Fast & Arlene King. Motion made by Doug to accept, Barb 2nd. Motion accepted. Nomination notifications will be mailed out to membership by September 1st. (delayed may be the holiday weekend.)

The show committee for the Perry cluster contacted Chris Bowker and had many questions Chris was unable to answer. Chris put Susan in contact with them. Much of the show information needed for the cluster is due by the end of October. The chairs suggested ATFTC hold 2 specialties on Saturday (a designated and one concurrent) then hold the National on Sunday. The cluster shows run from Wednesday -Saturday and Sunday is designated for combined specialties. Cindy made a motion that we go with the Cluster's suggestions. Motion seconded by Terrie & Jerry. Motion was approved. Dates are April 13th – 17th, 2022.

Discussion of the Cluster's judging panel vs our judge selections. We discussed picking from their panel for the regionals. Cindy asked for recommendations as

this is not needed until October 1st. The AKC application needs to be sent soon, Terrie volunteered to submit.

Susan will check for a general membership meeting room on the grounds.

Cindy questioned contracts for judges- need for both juniors and sweepstakes judges? Terrie will be willing to send out the contracts. Also discussed the need to send copies to all the board members in the future.

Further discussion of the cluster's events: Susan will investigate a banquet facility on the grounds and has the understanding the food served is excellent.

The need for a show chair is evident. Billy offered to be listed as the chair for the National. Cindy will not be able to attend but would be happy to be listed as well. This deadline is September 30th, 2021.

Discussion regarding Stewards- We will need stewards, Susan suggested hiring from the Steward's Association.

Susan made a motion to hire stewards from the Steward's Assoc to cover our specialties (that are not associated with the all-breed shows), for both of our Saturday and Sunday events. Motion carried.
