VETERAN SWEEPSTAKES PRIZES

The American Toy Fox Terrier Club offers Rosettes for Best in Veteran Sweepstakes & Best of Opposite Sex to Best in Veteran Sweepstakes & Flat Ribbons for First, Second, Third & Fourth in each Class.

FUTURITY

The ATFTC National Specialty Show Futurity shall be held before the American Toy Fox Terrier National Specialty Show and Sweepstakes. Should the ATFTC Specialty not be held within the time limits applying to the Futurity Rules, the Board of Directors shall decide the disposition of the monies accrued toward the Futurity Stake. The Futurity Stake is open only to breeders who are active members, in good standing, of the American Toy Fox Terrier Club. The Futurity Stake entries are only eligible by nomination of the litter. The get from this litter are eligible to compete in the first annual Futurity Stake held on or after the date they reach six months of age, and only in this stake. The bitch whose litter is nominated must be owned (or leased) in whole or part by a ATFTC member. Thus, if a bitch is co-owned or leased by two people, at least one must be a ATFTC member. This requirement does not apply to the owners of the puppies from the nominated litter.

NOMINATION DEADLINES

The nomination of the bitch's litter must be made after she is bred, but before the whelping date. Nominations are non-transferable, and may not be assigned to another bitch in the event of a non -litter. The nomination of each individual puppy must be made after it is whelped, but before it is four months old.

PROCEDURE FOR NOMINATING LITTERS

Any active ATFTC member in good standing may nominate a litter for the Futurity. The nomination must be made on an official Futurity entry form which can be obtained by writing to the Futurity Chairman. Said litter nomination must be made prior to the whelping of the litter. The determination date for timely nominations shall be the postmark on the envelope, which must be dated no later than midnight the day prior to the whelping of the litter. The breeder shall be supplied with a confirmation of nomination of the litter. A form shall be provided to the breeder for the purpose of notifying the Futurity Chairman of the whelping date, number and sex division in the litter nominated. This form must be returned within one month of the whelping date.

The nomination of a litter qualifies any of the litter for entry in the Futurity Stake, regardless of the ownership of the individual puppy when entered or shown. All nominations must be made before the puppy to be shown in the Futurity reaches four months of age, on an official Puppy Nomination form which can be obtained by writing the Futurity Chairman. If the breeder wishes to nominate all puppies in the litter individually, this may be done at any time after the date the litter is whelped but before it is four months old. In such cases, fees for all puppies in the litter must be paid and nomination forms sent to the Futurity Chairman. If neither the AKC litter number, nor the individual registration number, has been received by the breeder at the time each puppy nomination is made, this information must be forwarded to the Futurity Chairman immediately upon receipt. If ownership changes after individual puppy nomination is made, the Futurity Chairman must be provided with correct information regarding (a) name of puppy; (b) registration number; (c) color; (d) sex, and (e) new owners name and address. If this information has not been received by the Futurity Chairman at least one month prior to the date of the Futurity, the dog in question shall be disqualified. The same rule shall apply to the change of the dog's name if such occurs at the time of registration.

ELIGIBILITY

The Toy Fox Terrier must be entered in one of the regular classes at the ATFTC Specialty Show if the Futurity is held in conjunction with the Specialty Show. If the Futurity is held in conjunction with an All Breed show, the dog must be entered in one of the regular classes at the show. When completing the entry form, the fact that the dog is to be shown in the Futurity must be indicated on the entry form. The entry fee for the Futurity class is an additional fee. This fee should be included with the regular entry fee for the class at the show. No Toy Fox Terrier will be eligible to compete in the Futurity which does not meet the following requirements: 1. Be from a litter which was nominated in a proper and timely fashion. 2. Have been individually nominated before it reached the age of four months, and: 3. Be properly entered in one of the regular classes at the show. 4. "Futurity Stakes" is to be written in as an extra class on entry form.

NON-MEMBERS Persons who are not a member of the American Toy Fox Terrier Club who wish to nominate litters for the Futurity may submit an application for membership with the nomination form for the litters nomination. In the event that the application for membership is accepted by the ATFTC, the nomination will be dated as valid according to the date received. If the application for membership in the ATFTC is not accepted, the nomination of the litter will be null and void, the nomination fee and membership dues will not be refunded. The Board of Directors of the ATFTC shall decide any dispute that should arise pursuant to this Futurity Stake at its earliest convenience.

LAPSING OF DUES Any member who, having nominated a litter fails to remain an active member in good standing with the ATFTC by lapsing of dues, or indebtedness to the club, or by suspension or expulsion, and has not been reinstated 30 days prior to the Futurity, shall lose all rights in the Futurity. Dogs nominated by the lapsed or suspended individual but transferred to the ownership of another

individual prior to lapse of dues, suspension or expulsion, or indebtedness may be shown as eligible. Monetary awards will be made in such instances only to the owner of the individual dog pursuant to Futurity prize rules.

CLASSES

The following classes will be provided for both dogs and bitches.

6 Mos & Under 9 Mos • 9 Mos & Under 12 Mos • 12 Mos & Under 18 Mos

Winners of each of these classes will compete for Best Futurity and Best of Opposite Sex to Best in Futurity.

MONETARY AWARDS

NOMINATION FEES:

35% shall be deducted from the total nomination fee purse to be used for Futurity expenses. This will be deposited in the ATFTC Treasury. This fund shall cover all expenses incurred by the Futurity Stake i.e. judges, printing, mailing, etc. The remaining 65% will be awarded as follows:

60% - Best in Futurity

60% - Breeder of Record

40% Owner of Record

40% - Best of Opposite Sex to Best in Futurity

60% - Breeder of Record

40% Owner of Record

Entry Fees/Awards

35% shall be deducted from the total entry fee purse to be used for Futurity expenses and will be held in the ATFTC Treasury. The remaining 65% will be awarded as follows:

- 1. Entry 40% First Place
- 2. Entries 40% First Place, 30% Second Place
- 3. Entries 40% First Place, 30% Second Place, 20% 3rd Place, 10% 4th Place

If less than four competitors, the balance will be divided among placements in that class. All placements will be divided the same – 60% Breeder of Record, 40% Owner of Record.

- 4. Ribbons shall be awarded through fourth place in each class. Rosettes shall be given to Best in Futurity and Best of Opposite in Futurity. The cost for each to be covered from the ATFTC treasury. Trophies may be given and solicited from members.
- 5. Monetary awards which are provided for, but cannot be given, whatever the reason, shall be retained by the club.

JUNIOR SHOWMANSHIP COMPETITION

NOVICE CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show.

OPEN CLASS: For boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show. Juniors which according to their records have completed the requirements to compete in the Open class but whose status is Ameri- can Kennel Club are limited to competing in the Open Class for a period of 90 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and may change their entry the day of

the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

After the judge has awarded the Best Junior Handler, the second place winner from the class that the Junior was awarded Best Junior Handler is to return to the ring to compete for Reserve Best Junior Handler.

NOTICE: Junior Handlers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, 919-233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTICE TO EXHIBITORS

- * All cell phones MUST be in silent mode when in the building.
- * Entries cannot be accepted, cancelled, altered or substituted after entries have closed. Entries close on Wednesday, May 8, 2024 at 12 Noon.
- * Entries are to be mailed with fees to: Thomas W. Baldwin, P. O. Box 243, Ludlow, MA 01056-0243. Entries received without fees and/or signature will not be accepted.
- * Make checks payable to Thomas W. Baldwin, Show Secretary.
- * Faxed/e-mailed entries will only be accepted if accompanied by valid credit card info.
- * All checks and money orders MUST be payable in US funds.
- * Entries not on official AKC entry forms are not acceptable.
- * Photocopies of entry forms without Agreement and Rules on the reverse side of the Official AKC entry form are NOT ACCEPTABLE.
- * An AKC Recording Fee of \$.50 for the first entry of each dog and a \$3.00 service fee for the first entry of each dog and a \$3.50 service fee for each additional entry of the dog All Recording and Event Service Fees are paid to the American Kennel Club. (There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Multi-Dog Classes or Special Attractions.)
- * The show will be open from 7:00 AM to 5:00 PM.
- * Equipment may be left in the building Wednesday, Thursday, Friday, and Saturday nights.
- * Dogs may NOT be left in the building at night.
- * Building will be locked between 8:00 PM and 6:00 AM each night.
- * Dogs may arrive any time before the scheduled time of judging.
- * No Mesh Crates, Puppy Pens, X-pens, Mats or Rugs are allowed.
- * No tables (other than grooming tables) will be allowed in the crating area.
- * Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or barred from competition by action of the show committee. If, because of riot, civil disobedience or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fee will be made.
- * Errors on entry blanks are the responsibility of the person making out the form. No entry fee will be refunded in the event of such error after the published closing date.
- * Neither the Club nor the Show Secretary will be responsible for loss or damage to any dog entered, nor for the possessions of any exhibitor or spectator. It is distinctly understood that every dog is in the care, custody and control of its owner or handler during the entire time the dog is on the show grounds.

From the North:

Take Rt. 95 South; exit left onto Rt. 4 South. Take the second exit on Rt. 4, Rt 403 East/Quonset Point. Travel approximately 2 miles on Rt. 403 East; take the Rt. 1 Post Road/Davisville Road exit. (Note- exit at Davisville Road- do NOT take West Davisville Road.) Bear left on the exit ramp toward Davisville Road. Drive approximately 3/4 mile, remaining on Davisville Road. WWIS will be on your left. From the South:

Take Rt. 95 North to Exit 8A, Post Rd/East Greenwich. Bear right off ramp and take immediate left at first traffic light (Division St). At second traffic light bear right onto Rt. 4 South ramp.
