#### UNFINISHED BUSINESS:

##### Judges for 2016 Nationals and Renewal Information

Rebekah's list of judges to be voted upon has been mostly compiled. She took Denise's suggestion and pulled the information off of InfoDog, and then removed all the judges that have judged a Toy Fox Terrier specialty in the last 5 years, and removed the ones that she could find from the regional specialties. There are 283 judges from the States and 163 from Canada that are eligible to judge Toy Fox Terriers.

## AMERICAN TOY FOX TERRIER CLUB PRESIDENT'S MESSAGE



Hello ATFTC members,

I hope this finds our membership doing well. We have been pounded with rain, not that I am complaining as we desperately need it, but I am already tired of slushing through the mud!

We have had a couple of Board Meetings since our last edition of Fox Tails was produced. Please review the minutes as printed elsewhere in this edition. It is your responsibility to know what is happening with the club and how the BOD is making decisions that affect our breed and club.

The membership is quite, not sure if that is good or bad. I know I can tell you we are in desperate need of some membership involvement. We are looking for a Show Chair for our 2016 National which will be held in December in conjunction with the Eukanuka National Show in Florida. We are also in need of someone who can assist with our webpage. We have a new domain and want to establish a new website that is friendlier to use (and maintain!). **Please contact me if you are interested in helping.**

We are starting to produce procedures for our various committees. This will ensure we are consistent in decisions as we move the club forward. As our membership grows and gets more involved, it will be easy to read procedures and know what is expected as a committee members and how decisions are made by the BOD.

The BOD is currently reviewing how we hire judges for our National Shows. This is where I want to **HEAR FROM THE MEMBERSHIP!** Since our club does not have the numbers to host a standalone National, we tag onto a show and host the National the day(s) before the all-breed shows. For example, this year our National is the day before the Eukanuba National Show. Hiring judges is always a hot topic and tends to get swayed one way or another by the person who screams the loudest. The Board is looking at a few possible procedures to hire judges. One is to send a

list of all TFT judges to the membership and let the membership vote. The issue with this is that the list will contain hundreds of judges and with low voter turnout (yes, very few of the membership has voted in the past) a judge can be picked by getting very few votes. This method can easily be manipulated by someone who wants to call around and advocate to vote for a particular judge since our turnout is so low. Cost can also be an issue, if we fly in a judge, put them up in a hotel, and pay a judging fee, we could be out a substantial sum of money and this may reflect in entry fees. Another possible procedure is that we utilize a judge that will already be judging at the show we are tagging onto. This would limit our choices and the BOD would tend to make the decision who judges based on timelines. By the time judges are announced, time to get a ballot out and returned cuts the timeline short. This procedure saves money, although I understand it is not always about the almighty dollar!! So, what do you think as members? Would one procedure over the other determine if you attend? Do you care about costs? Do you think your BOD would make a decision that you feel was done with the utmost integrity? Can you think of a better procedure? The feedback I receive from the membership will greatly determine the decisions I personally make regarding a procedure. Let me know via email ([kingsminirex@msn.com](mailto:kingsminirex@msn.com)). 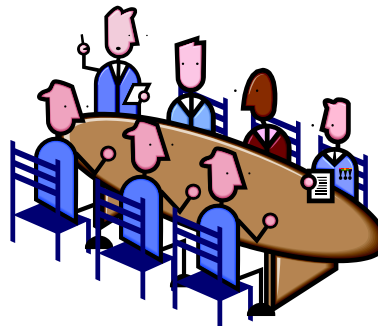

## World without the AKC

It's time to start thinking about a world without the American Kennel Club.

Unless the AKC matches the political machine in every state capital put there by the Humane Society of the United States, it's only a matter of time until the great ship that is the AKC sinks below the waves.

It is not reasonable to continue to expect volunteers to do the heavy lifting of politics and legislation. It's hard work, and it's not everyone's cup of tea. HSUS has paid, experienced, trained professionals in front of lawmakers every day.

But the AKC seems to think volunteers can handle it.

I think the AKC in general is on life support, and they're heading in a very dangerous direction. While they've been casting about for new revenue streams for years, the opposition has built a political machine in every state capital to advance their very organized and well-funded political movement for social change. It's a political agenda for social change that seeks a world without purebred dogs and eventually no dogs at all. If you think that's an exaggeration, then you're not paying attention to the very real and dangerous changes to dog ownership that are sweeping the nation. If you think this professional political agenda for social change could never happen, you're mistaken. Twenty-five years ago not many of us truly believed gay marriage and legal marijuana would ever become a reality.

There are six people on staff of the AKC's Government Relations Department in Raleigh. They are dedicated professionals who understand the challenges we face. I know them, and I've worked with them for almost a decade. They are fantastic people, and they are amazing at what they do. But there are only six of them.

There are many dedicated volunteers all across the country who work very hard in their AKC State Federations of dog clubs. Some of them are very effec-

tive. Some of them are not. They do the best they can as volunteers. It's not reasonable to expect more from them when they have jobs, families, and dogs to care for outside of volunteering to fight a professional political battle.

Nothing illustrates this point better than the wave of anti-pet shop legislation currently sweeping the nation. Although I was not surprised, I was heartily disappointed that not one breeder, club or federation person had one word to say in Augusta about the ban on pet shops in Maine. Not one.

United States federal law doesn't care what kind of dog breeder you call yourself. If you have five females (and you ship a puppy just once) you're a pet shop. Got that? How long do you think it will be until the "if you ship a puppy" clause is removed? How long do you think it will be until the number five is reduced to three?

The United States government does not care that you call yourself "responsible, ethical, only-do-it-to-better-the-breed, oh-my-god-I-would-never-sell-or-buy-a-puppy-at-a-pet-shop".

All dog breeders have a right to breed dogs in the manner they choose to breed them. You don't have to like what others do, but you have to allow them the right to do it. If they don't have that right, then neither do you. Different is not bad. Substandard is bad.

The only thing two dog breeders will ever agree on is that a third dog breeder is doing it wrong. The opposition knows this, and they very effectively use it to drive wedges between all sub-groups of dog breeders. Dog breeders fight among themselves and scramble to condemn others while the opposition gains ground attacking all dog breeding. Dog breeders are doing the work of the opposition for them. Dog breeders are being played.

I was president of my all-breed club for many years. I served as an officer in my state's AKC Federation. I served as legislative liaison to my national parent club. In all that time there were two comments that I heard from folks time and again. The first was the misguided belief that this political movement for

social change doesn't affect them. The second was the pitiful cry of "Why doesn't AKC do something?"

I don't understand how so many folks continue to stick their heads in the sand and refuse to believe that this political movement for social change does not affect them, but I do understand why the AKC "isn't doing something". Quite simply, it's not their job, and it never has been.

The nineteenth century founders of the AKC could never have imagined that a professional political movement would seek to abolish purebred dog ownership in the twenty-first century. The nineteenth century founders of the AKC created a volunteer structure that served us well for over a century, but it's our biggest weakness in this fight against a professional political movement.

To its credit, the AKC does have some pieces of a political machine in place that mirror the opposition: the AKC has a political action committee, and they have professional lobbyists in Washington, DC. While the Humane Society of the United States' pays full-time professionals in all 50 state capitals, its current goal is to get volunteers in each of the nation's 435 congressional districts. The AKC already has club members in all 435 congressional districts across the nation. But the AKC does not have paid professionals in all 50 state capitals. This is our biggest weakness because the political battle is being waged at the state and local levels.

I've been fighting this battle as a volunteer for almost a decade. I've seen first-hand how the opposition does not want us at the table in our state capitals and municipal councils. The opposition wants to create their version of public policy in a vacuum, and we're letting them do it by pitting part-time volunteers against full-time professionals. It's part of the legislative process for amendments to legislation to be proposed at the last minute. It's part of the process for important meetings to be scheduled with very little notice. It's not reasonable for the AKC to continue to expect volunteers to drop everything in their busy lives at a moment's notice to be part of the legislative process. Nobody has time for that when it's not their job.

It seems like an easy solution on the surface, but I fully understand that it would

# AKC Companion Events

## **ACT PROGRAM** **(AGILITY COURSE TEST)**

The Agility Course Test (ACT) is an entry level agility event designed to introduce and welcome beginning dogs and their handlers to the AKC sport of agility.

There are two levels of ACT events – ACT1 and ACT2. ACT1 is designed for the beginning level dog to show beginning sequencing and performance skills. ACT2 requires an increased skill level shown by the additional obstacles to be performed.

In addition to showing their dog's entry level skills, exhibitors will learn to fill out an AKC entry form, check-in at the ring, taking their dog in and out of ring, handling their dog while being judged and other information that will help them when they move on to AKC agility trials with their dog. Dogs must be 15 months old to enter these events. They do not need to be AKC registered at the time of entry.

## Report from Dr. Gregory Lawson DVM

In the last quarter of 2015 the following numbers of TFT were tested for the conditions listed:

In regards to trends from 1998 to the present, hips and elbows have the lowest testing incidence and the numbers tested have remained steady averaging 4 dogs per year for hips and 2 for elbows. This year saw an increase in cardiac testing likely due to the clinics provided by the club. From 2004 to 2014, an average of 4 dogs per year were tested. However, for 2015 a total of 16 dogs were tested. Luxating Patella testing, from 1998 to present saw an average of 13 dogs tested and registered per year and of those only 6% had abnormalities. The first registry for Primary Lens Luxation was 2010, which saw the greatest number of dogs tested (248), however since that time, an average of 54 dogs were tested per year. The first registry of dogs tested for Spinocerebellar Ataxia was 2014. We have seen a significant rise in testing from 26 in 2014 to 70 in 2015. It is nice to observe that of those tested, only 2.86 have been recognized as abnormal even though 20.95% were tested as carriers.

I am happy to see that people are registering abnormal as well as normal findings. Without that, the actual incidence of disease conditions is skewed and will not reflect our breed as a whole. It is also critical to remember that a carrier is not a death sentence or a reason to not breed a dog. It is there to make you aware of how to select your stud dog (clear). Additionally, by testing the offspring you plan to keep and selectively breed, one can eventually weed these conditions from a breeding program. I would hate to see people get rid of an exceptional dog because he or she is a carrier – it would be like “throwing the baby out with the bath water !!”
